Company Background

Golden Palm Oil Industries Sdn. Bhd (GPOISB) was registered on 29 June 1990 as a private limited company dealing in trading and stockist of palm oil products. It took over the operations of Asahi Enterprise in 1991 which had been a sole proprietorship concern established in 1984 and owned by one of the directors.

GPOISB forayed into the palm oil business, started as a packer of refined, bleached and deodorized palm oil for a number of corporate clients. This activity was later expanded when GPOISB became a distributor of refined, bleached and deodorized palm oil catering for the Klang Valley market.

GPOISB's production/packing facilities are carried out in two factory premises. The production setup comprises a number of dedicated storage tanks each fitted with either automated packing lines or manual handling packing equipment to suit the size and specifications of the packaging required by the clients. The overall production and packing lines are managed by 20 production operators and 5 administrative staff. All products adhere to the standards required by the relevant bodies/authorities including the "Halal" certification.

The company has a storage capacity of 140mt at any one time and a packaging capacity of 1500mt per month.
